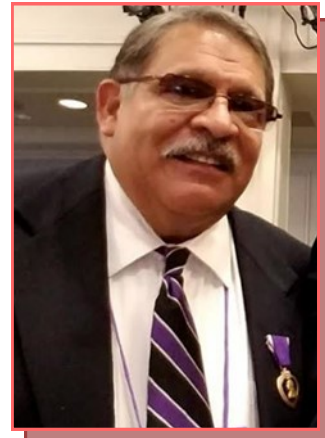

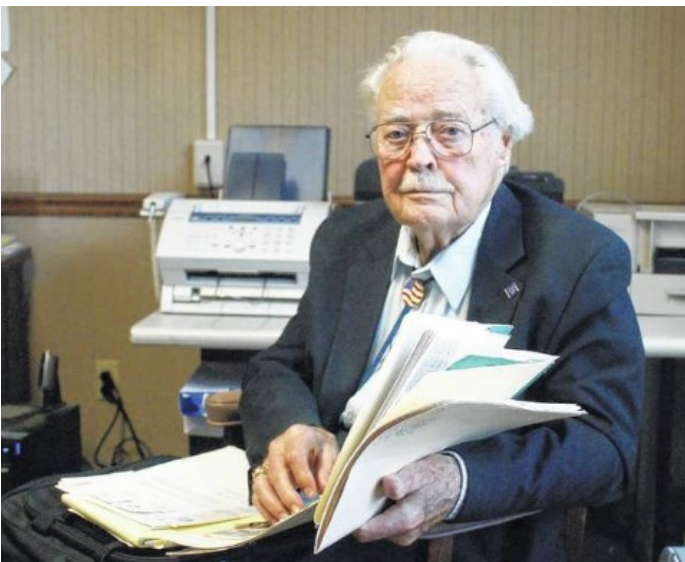

### **PATRIOT BOB DOLE RECEIVES GOLD MEDAL FOR WAR & POLITICAL SERVICE WASHINGTON, D.C.**

Robert Joseph “Bob” Dole, of Russell, enlisted in the U.S. Army Reserves Corps in 1942, and summoned to active duty in 1943.

Upon completing training programs in the U.S. he became a combat infantry officer and was sent to Italy. In April of 1945, while in combat near Castel d’Aiano in the Apennine mountains SW of Bologna, Italy, he was severely wounded by a German machine gun, while trying to rescue a radioman. Patriot Dole had sustained a shattered right shoulder, fractured vertebrae in his neck and spine, paralysis from the neck down, metal shrapnel throughout his body and a damaged kidney.

He was transported back to the U.S. and recovered at the Percy Jones Army Hospital, which is now named Hart-Dole-Inouye Federal Center, in honor of the three patients who became U.S. Senators. Dole was decorated three times, receiving two Purple Hearts and the Bronze Star with combat “V” for valor for his attempt to assist the downed radioman.

After his Army days, Patriot Dole went on to serve in the Kansas House of Representatives, the U.S. House of Representatives and U.S. Senate. – serving in several leadership positions within his party, including Majority and Minority Leader, and even bid for the Vice Presidency and Presidency.

Patriot Dole spends countless hours visiting young men and women who have been wounded in combat. He has been a member of MOPH since 1970. [Read full story here.](#)

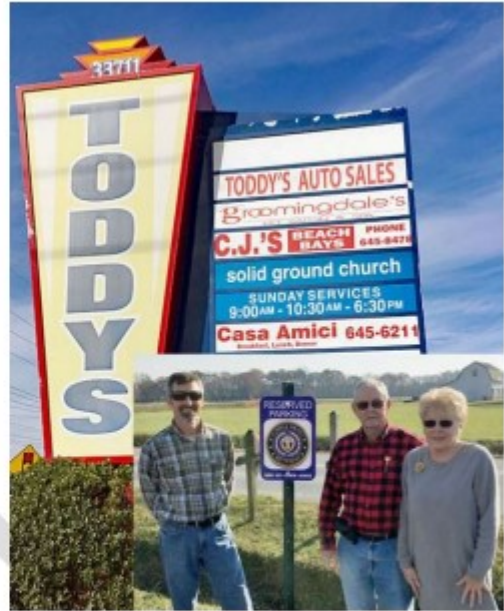
## CHAPTER 1787—VA

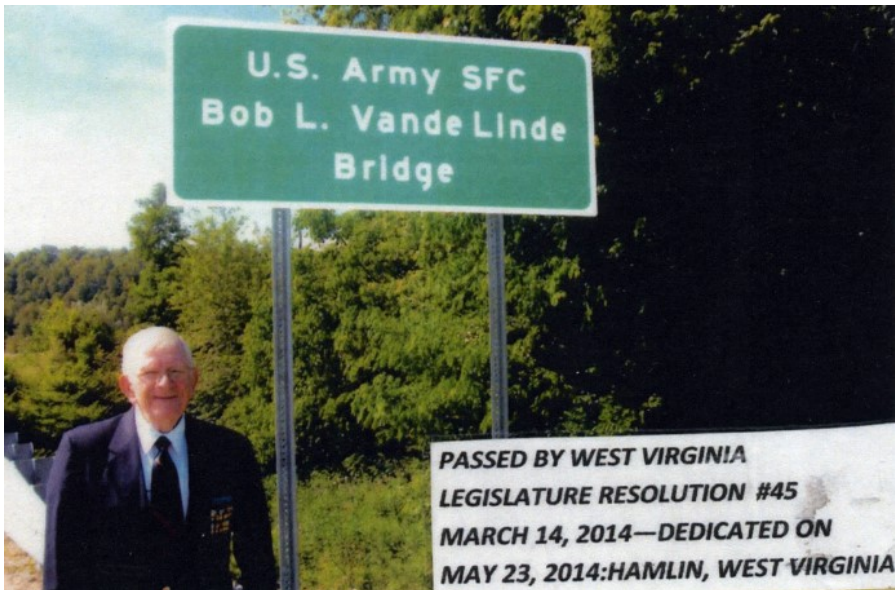

## CHAPTER 1607—VA—PATRIOT BOB VANDELINDE

Patriot VandeLinde was assigned to the 187th Airborne Infantry at Fort Campbell, Ky., in 1948 and, two years later, he was a paratrooper in the thick of the Korean War. On Oct. 22, 1950, VandeLinde and his eight-man unit came into combat with a group of 200 enemy troops whose encampment was just down the road from their outpost on the outskirts of a Korean village.

The Hamlin, W.Va., native's service earned him numerous decorations in combat including the Purple Heart, the Silver Star, a Korean Presidential Citation and Service Medal and a Combat Infantry Badge among many other honors.

In 2011, VandeLinde was also declared as the "Warrior of the Day" and in May 2014, a bridge that spans the Mud River on W.Va. 3 in Hamlin was renamed the "U.S. Army SFC Bob L. VandeLinde Bridge" at a dedication where Medal of Honor recipient and good friend Woody Williams spoke. [Read full story here.](#)

George was born in Bristol, CT on August 15, 1917 and was the son of the late Andrew and Mildred Holcomb Crowley. He served his country faithfully in the U.S. Army during WW II in the Pacific, HQ. 1st BN. 169th Infantry 43rd Division received the Purple Heart and the Division Medal of Honor.

George had worked as a supervisor for Pratt & Whitney for many years until his retirement. He was a life time Mason; member of the New Haven Raccoon Club and a member of the V.F.W. George was an avid sportsman.

It was Feb. 14 and amidst the chaos of the attack, Brown was on the radio coordinating a counter attack as he was familiar with the outlying enemy positions. Viet Cong had carefully coordinated the attacks to target bunker positions and inflict maximum damage.



Brown was hit and sustained the most serious injuries — shrapnel wounds from his waist to his head, with only his thumbs spared. In addition to the shrapnel wounds, he sustained broken fingers and a severe concussion.

Having already shed 40 pounds humping through the challenging terrain in Vietnam, Brown was flown to an evacuation hospital in country, then shipped to the Philippines and later to Japan. He spent weeks hospitalized and weeks more in rehabilitation. [Read full story here.](#)

### DEPARTMENT OF PENNSYLVANIA—PATRIOT WILLIAM GRANT RECEIVES BRONZE STAR

The Nevada National Guard presented Pvt. William Grant with the honor at the Clark County Armory.

Grant served in Normandy with the 60th Infantry Regiment in the U. S. Army and was wounded in battle.

His son, Bill Grant had researched his father's military records and found out he had been awarded the Bronze Star, but no one had ever physically given it to him. Bill contacted Veterans Affairs to do just that.

"I am thrilled and honored to be able to have these medals presented to my dad after such a long time," Bill said. "As part of the 'greatest generation' he is truly a hero, a quiet hero, who served his country and his family."

William Grant received the award while his family was in Las Vegas for the holiday season. He earned a Purple Heart and campaign ribbons after leaving the military in 1945. "We need to cherish the World War II veterans still with us, honor those who have passed and never forget their sacrifice," Nevada Army National Guard Commander Brig. Gen. Zachary Doser said.

William Grant, a Las Vegas resident, was born in Pittsburgh, Pennsylvania. He graduated from Pitt University and worked with the Social Security administration for several decades in Baltimore before moving to Nevada. [See full story here.](#)



### DEPARTMENT OF PENNSYLVANIA—REP. RYAN COSTELLO AWARDS PURPLE HEART TO CHESTER COUNTY ARMY VETERAN, PATRIOT JUSTIN RADBILL



U.S. Army veteran Justin Radbill, left, is awarded the Purple Heart by U.S. Rep. Ryan Costello, R-6, at a ceremony in West Goshen Wednesday.

More than 50 family members, friends, veterans, Purple Heart award recipients and state police officers crowded into the Chester County Office of Veterans Affairs, at the Chester County Government Services Building, in late December. Costello pinned the award for injured military personnel onto the U.S. Army veteran's coat.

Pvt. First Class Radbill was injured in Baghdad, Iraq during June of 2003 and although a ceremony took place, he never was awarded the actual medal.

Radbill walks with help of a cane and will undergo more surgery next week after an improvised explosive device (IED) detonated and he was struck with shrapnel, while also suffering other significant injuries.

Vietnam veteran and Purple Heart recipient, Patriot Dennis Kukulka, from Chapter 1777 was among those who recognized Radbill's sacrifices.

Palmentieri, who was awarded a purple heart after being shot by a German sniper in France, lived on Boston Avenue, which was renamed “Purple Heart Way” in honor of him and his three brothers.

Before being drafted, Palmentieri was a high school student in Atlantic City. Palmentieri did not arrive in France until after the D-Day invasion, he said the fear still existed.



In the hospital, Palmentieri met Ray Borzellino, a medic who lived around the corner from Palmentieri in Atlantic City. After the war, Palmentieri married Borzellino’s sister Louise, whom he met at the Veterans Administration Office. Louise was working for the VA at the time, and the two were married for 70 years. 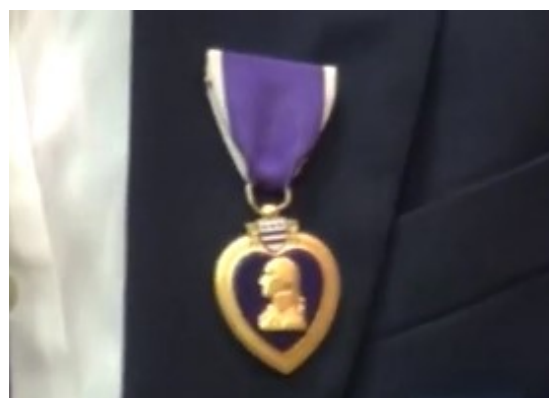

Harry Kerr, the Chapter's adjutant, said the Chapter's name is adopted to remember two local soldiers who died in combat: Sgt. Allen Lloyd, who died in Cambodia in 1971, and Lance Cpl. Curtis Swenson, who was killed in Afghanistan in 2010.

### CHAPTER 583—MT—PATRIOT JACK HENLEY RECOGNIZED BY CONGRESSMAN GREG GIANFORTE

Rep. Greg Gianforte was in Hamilton to honor WWII and Korean War veteran Jack Henley. He presented Henley with a certificate of his tribute made on the House floor back in November 2017.

Henley joined the US Army right after graduating from high school in 1943 and attended boot camp in South Carolina before being sent to Guadalcanal where he earned a pair of Bronze Stars.

He was then sent to the Philippines where he safely led a squad of men through cannon, mortar and automatic gunfire. He returned to the battlefield twice and saved two wounded men in the process. Henley earned a Silver Star and Purple Heart while in the Philippines. Following World War II, Henley took some time off from the military but then

re-enlisted and served during the Korean War as a drill instructor. By the end of Henley's 28-year career, he had been awarded 18 medals and decorations and his name is included in the Hall of Valor in Washington D.C. [Full story here.](#)

The ceremony for 94-year-old Sylvan Vigness, of Flandreau, was held on January 27th at the Flandreau Community Center. His 89-year-old wife, Iona, was asked to pin the award on her husband's sweater.

Sylvan Vigness served on the USS Hinsdale as petty officer and signalman. He injured his left eye in 1945 during a Japanese kamikaze plane crash onto his ship headed to the initial landings at Iwo Jima in the western Pacific. He wasn't treated until months later. [Read full story here.](#)

## CHAPTER 642—NORTH CAROLINA

The annual “Purple Heart Memorial Tree for KIA’s” that Chapter 642 displays each year for over 10 years at the PX on board the Marine Corps Base at Camp Lejeune, NC. There are aver 528 names of Marines and Navy Corpsman from the II Marine Expeditionary Force on the large board that have died while serving in Afghanistan and Iraq since 2003 to present. The large tree contains a large purple ball for each year and number killed during that year. On the large board are the names, ranks, and year killed of each member. More than 100 such signs have been placed in the parking lots of businesses and government facilities in Coffee, Dale and Geneva Counties, according to Patriot Robert Green. “Even if the parking spot is empty, it’s a good reminder for those who walk or drive by.”

A three time Purple Heart recipient, Patriot Green is the person credited for making the city of Enterprise aware of the significance of attaining a Purple Heart City designation. He is also the Commander of the one-year-old MOPH Chapter 2216 in Enterprise, AL.

Increasing public awareness of the significance of the Purple Heart parking is a mission Green takes seriously. “I want people to understand what the sign means,” Green said. “It means a lot to me and it means a lot to my brothers and sisters that are combat wounded. “The Purple

Heart parking signs are a way of saying ‘thank you’ to the men and women who spilled blood for our country. It’s just respect” Green said.

### PASSING OF PATRIOT DALE BEATTY—ARMY VETERAN, PHILANTHROPIST & CO-FOUNDER OF **PURPLE HEART HOMES**

Patriot Dale Beatty, an Army veteran from Statesville, NC who lost both legs beneath the knees in Iraq and devoted his life to helping other veterans, died unexpectedly Monday at age 39, as reported by Purple Heart Homes.

Patriots Beatty and John Gallina, also from Statesville, were wounded when a mine detonated through the floor of their Humvee in northern Iraq in 2004. The two friends were in high school when they enlisted in the North Carolina National Guard in 1996.

Together they founded Purple Heart Homes in 2008 because many injured veterans need new homes when they return from conflicts. Others need improvements to their homes, especially as the veterans age and can't do the repairs themselves. The organization has helped veterans in the Carolinas and other states coast to coast with new or renovated homes, often with volunteers providing everything from donations to labor. Purple Heart Homes completed its 300th housing project in November, 2017.

### CHAPTER 1513—TEXAS WELCOMES PATRIOT SHELBY DAWSON

Department of Texas, Adjutant Jon Lunkwicz signed up Shelby S. Dawson, a WWII US Marine, that was wounded on July 26th, 1944. He received his Purple Heart on October 20, 2017... 73 years later.

Dawson also became one of the oldest, if not the oldest Marine, to ever receive the Purple Heart Award. A crowd of more than 200 people came to watch Dawson receive the honor which he earned more than seven decades ago.

Dawson enlisted in the Navy when he was 17 years old. At that time, according to military records, the award was given to those “wounded” by an enemy. But Dawson had a hard time proving that happened. And that’s how the I-Team first met him back in 20-16.

Dawson told CBS11, in 1944, days into the invasion on Guam, a mortar around exploded near him. “The explosion knocked me kind of silly. I reached down to pick up my M1 and my hand won’t work.” Hit by shrapnel, he made it to the medical tent where a doctor told him he needed to go to the hospital ship. [Read full story here.](#)

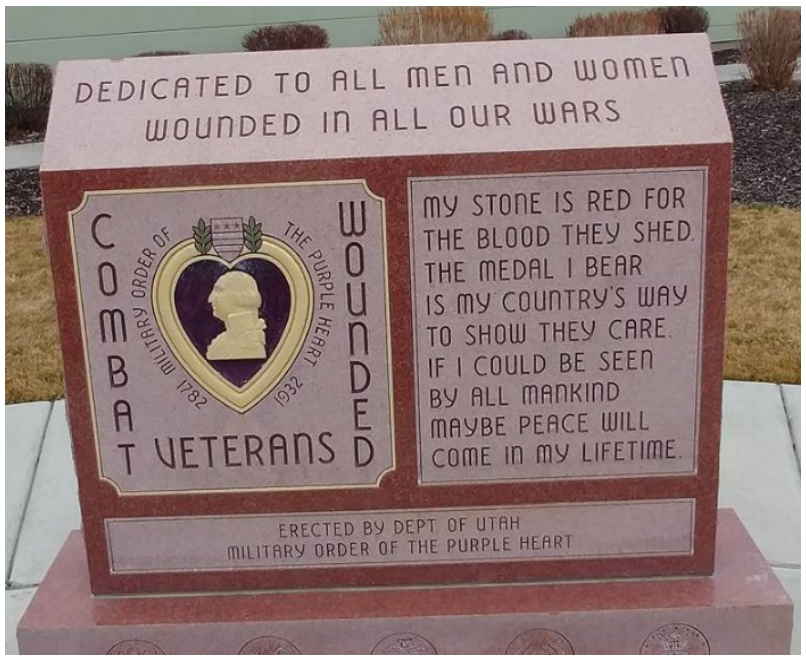

Patriots of Chapter 385 and the Auxiliary Unit 385 walked in Folsom, California parade. MOPH was first to follow the Honor Guard.

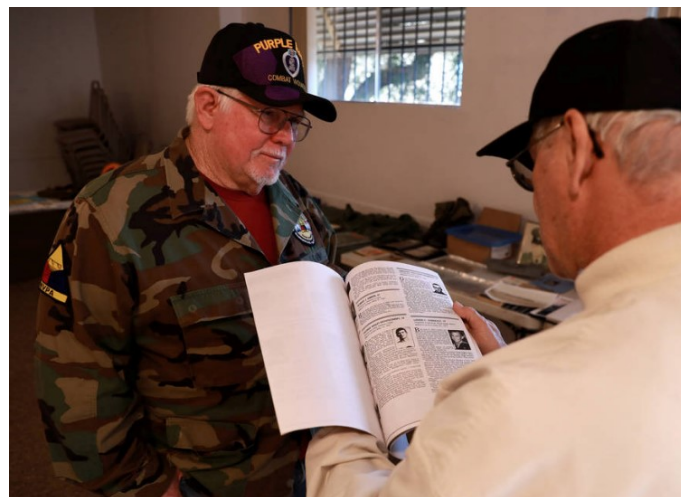
