The completed Election and Finance (when applicable Property List and 990 receipt) reports can be mailed to Headquarters, faxed to (703) 642-1841 or emailed to membership@purpleheart.org. Americanism, VAVS (Department Only), and Welfare reports are to be submitted directly to the National Officers indicated on the reports.

Chapters: Don't forget to submit copies of all reports to your Departments.

Please note the “earlier” reporting dates on the form **Key Dates** (see Page 5). These changes have been implemented to support the National Convention in July so all of our members can observe **August 7** at home.

UPDATE

ROTC / JROTC PROGRAM - SPRING 2018

- ◆ MOPH is now charging \$15.00 for each ROTC/JROTC Award Package.
- ◆ Additionally, MOPH will be charging a \$25.00 fee for replacing a complete Award Package due to it being lost, misplaced or damaged after being presented to the recipient.
- ◆ Individual award elements (medal \$15), (certificate \$10), and (folder \$5) can also be replaced.
- ◆ All replacement requests must be received from a Chapter representative or the appropriate ROTC / JROTC Instructor.

We are pleased to report that Chapters and Departments have been reaching out to Stewart McKeown, ROTC Coordinator, to place their orders along with payment for the same.

Similarly, schools without an MOPH point of contact continue to reach out to MOPH Headquarters directly or go online to order the award. When fulfilling these orders, the schools are provided with contact information for a local MOPH representative, however, they are not always successful in arranging for a MOPH presenter.

We would like to clarify, that the **ONLY** change to the ROTC / JROTC order process is that there is now a per award charge of \$15.00.

It is up to individual Departments and Chapters to determine whether they will pay for the awards and then contact their local ROTC/JROTC programs to work out presentation details.

Chapters and Departments should continue to send their list(s) of schools to Headquarters by email (rotc@purpleheart.org) or mail accompanied by a check to cover the cost of the award(s) ordered. Awards are shipped upon receipt of payment to arrive about two weeks prior to the ceremony date.

Dear Congressman Connolly:

On behalf of the Military Order of the Purple Heart (MOPH), whose membership is comprised entirely of combat wounded veterans, I am pleased to offer our support for H.R. 1928, the *Families of Fallen Servicemembers First Act*, which would ensure that military surviving families do not experience any delays in receiving death gratuities and related benefits in the event of a government shutdown.

When a servicemember dies on active duty, his or her family is entitled to a tax free payment of \$100,000, known as the death gratuity. Bereaved military families rely on this money to meet any financial hardships they may incur, immediately following the loss of their loved one. Like you, MOPH strongly believes that no family entitled to this relatively modest benefit should ever have to experience a delay in payment, simply because Congress temporarily fails to perform its primary duty of funding the U.S. Government.

When servicemembers put on the uniform each day, whether in combat or in peacetime, they take comfort in the fact that their families' basic needs will be met, should something happen to them. Under no circumstances should political gridlock ever put those families in financial jeopardy. Your legislation would prevent this from ever happening again, ensuring that this sacred promise to those who serve our nation is kept.

MOPH thanks you for your leadership on this issue, and your commitment to servicemembers, veterans and their families. We look forward to working with you to ensure the passage of this important legislation.


I am proud of each of them and honored to have them in my charge.

UPDATES TO THE MOPH NATIONAL SERVICE PROGRAM

National Service Director Angelo Wider has announced several structural and staffing changes to the National Service Program.

Effective *January 14th*, the program's geographic organization will be broken down into four areas (from six regions). Each area will have an Area Manager and seven key states will now have a Senior NSO appointed to help manage affairs in their respective states.

This is one of several initiatives being taken by MOPH leadership to improve efficiency, establish standardization and controls, as well as contain costs. Other actions planned for 2018 include systems upgrades, focused training, increased outreach and updating the NSO Policies and Procedures Manual.

According to NSD Wider, under the new structure, the Area Managers and Senior NSOs will collaborate with MOPH Departments and Chapter Officers to pursue more state funding to support the National Service Program and NSO positions in the state. The kick off of the "NSP Fifty State Review" will result in action plans to pursue grants and other funding by states. (Questions please email: servicedirector@purpleheart.org)




